## VI. OLD BUSINESS

1. Metal Recycling Charge - Mr. Cirioli to check into it and report back at a future meeting. It was reported by Ms. Ostuno from H.W. Green Recycling, that the town is receiving a reimbursement for scrap metal. **Ongoing**
2. Simple Recycling – Rich emailed Mr. Cirioli, he is on vacation. Will be discussed at the next meeting. **Ongoing**
3. Recycle Coach – Mr. Cirioli explained that the town opted to upgrade the current recycle coach program. He went over specifics and will report to the commission when it goes “live”. **Ongoing**
4. Battery Recycling – the commission asked if it is possible to start battery recycling. Mr. Cirioli will talk to the Town Manager, Fire Chief and Fire Marshall for more details, including possible location for a collection box. **Ongoing**
5. Fluorescent bulb recycling – George Fensick asked if it is possible to start a recycling program for fluorescent light bulbs. Mr. Cirioli to talk to town staff and report findings at a future meeting. **Ongoing**
6. Nip Bottle Recycling – Kathy Cole asked about “Nip Bottle Recycling”. It is possible to put a recycling bin by the bus stop by the Fire Department? There seem to be several nip bottles on the ground there. Commissioner Ireland to ask Mr. Cirioli if it is possible and report at an upcoming meeting. **Ongoing**
7. Hazardous Waste Collection – Rich to find out when the next one is, he believes it will be in Bristol, will inform at next meeting. **Ongoing**
